

# PROCEEDINGS OF THE DEPARTMENT OF HAWAII, 85<sup>TH</sup> CONVENTION CONDUCTED AT THE ALA MOANA HOTEL, HONOLULU HAWAII

**FRIDAY JUNE 10, 2022**

1. THE 84<sup>TH</sup> DEPARTMENT OF HAWAII VFW CONVENTION WAS OPENED IN FORM BY COMMANDER BRAGG; AT 09:12 AM HST AT THE LANAI GARDEN BALLROOM OF THE ALA MOANA HOTEL IN HONOLULU, HAWAII, ON JUNE 09, 2023. THE STATE ADJUTANT BARLETT WAS PRESENT.
  
2. INTRODUCTION OF GUESTS:
  - A. State Adjutant Barlett introduced the following guests.

3. FIRST CREDENTIALS COMMITTEE REPORT
  - A. QM Enos moved that the roll of delegates submitted as of 08:30 AM being the official roll of voting members of the convention: Posts Presents 15 Post Delegates: 99 Officers voting separately 0; Number of delegates entitled to vote 99.
  - B. The Credentials Report was accepted final report will be adopted tomorrow.
  
4. READING AND ADOPTION OF CONVENTION RULES
  - A. State Judge Advocate Randy Grant read the Convention Rules for the 84<sup>th</sup> State Convention and moved the adoption of the proposed 85<sup>th</sup> Convention Standing Rules.
  - B. The following Convention Standing Rules were adopted as read.

**General:**

    1. With the exceptions listed below, Robert's Rules of Order Newly Revised will be recognized as the Parliamentary Authority.
    2. The Commander shall appoint all committees for the functioning of the Convention.

3. The Commander shall control all discussions on resolutions, elections, and other issues to be voted on. All delegates entitled to speak shall be recognized by the Commander.
4. The consumption of alcoholic beverages is prohibited in the Convention Hall during official business sessions.
5. Mobile communication devices shall be either turned off or placed on silent or vibrate mode.
6. The chair shall have the authority to escort from the Convention Hall any person interfering with the orderly proceedings of the convention.
7. Only the State Commander or their designated representative may release Convention information to outside information to outside agencies, such as the Press, following decisions made at this Convention.
8. The Convention rules may be suspended at any time by a two-thirds (2/3) vote of the delegates assembled at a Convention, to be taken without debate.

**Voting:**

1. All votes cast must be paid for. This includes Delegate votes, Commanders votes, State Officers votes, National Councilmember vote, and Past Commanders votes. Delegate fees will be applied as follows:
  - a. Post delegates as determined by Post strength on record with the Department Quartermaster as of June 8, 2023.
  - b. Other votes include Post Commander's votes, State Officer's votes, Past Department Commanders vote, and Current National Councilmember vote.
  - c. In accordance with Section 521, of the Congressional Charter and Bylaws, NO person shall have more than one vote.
2. Voting shall be by acclamation except when a Roll Call vote is requested by three (3) delegates from three (3) different Posts.
3. Each delegate shall not be considered instructed or acting as a proxy.
4. When the roll is called, the Delegate chair shall announce the vote of their delegation.
5. Each delegation may arrive at a vote in any manner, but shall announce it in terms of full units and not a fractional part of a vote.
6. When the roll call of a delegation chair is not acceptable to any member of the delegation, the Department Adjutant shall poll that delegation for clarification.
7. Roll call voting order shall be Post Commander and Post delegates in numerical order, Past Department Commanders, National Councilmember, Department Officers, State Junior Vice, Commander, State Senior Vice Commander, and State Commander.
8. Delegates may abstain on the first round of a roll call, but must cast their vote on the second round.

**Delegate Recognition:**

1. Any delegate entitled to speak shall go to an appropriate microphone or use the hand microphone as appropriate.
2. Any member wishing to offer any parliamentary action shall inform Officer of the Day or Sergeant at Arms who will inform the Commander.
3. The delegate shall **be recognized**, address the chair as "Comrade Commander", state their name and Post Number or in the case of a Department Officer, they shall state their title; e.g. James Jones, delegate from Post 123 and then speak.

**Motions:**

1. All motions and amendments shall be submitted in writing.

**Debate:**

1. Debate shall be limited to two (2) minutes per speaker.
2. A delegate is permitted to speak, but twice on any subject or resolution, except by consent of two-thirds (2/3) of the voting strength present. Committee Chairs may speak as necessary to clarify the motion.

**Bylaws Amendments:**

1. The 2022-2023 Bylaws Committee shall be authorized to correct article and section designations, punctuation, and cross references and to make such other technical and conforming changes as may be necessary to reflect the intent of the membership in connection with bylaws amendments adopted at the 85<sup>th</sup> Convention.

**Election Rules:**

1. Nominations and election for each office shall be done in the following order: Commander, Senior Vice Commander, Junior Vice Commander Quartermaster, and Chaplain.

2. Nominating speeches for candidates to any elected position shall be limited to two (2) minutes each. Seconding of a candidate is not required but, only one seconding speech of two (2) minutes shall be made for any candidate.
3. Candidates are allowed 3 minutes to speak.
4. Voting shall be by Roll Call vote.

## 6. BYLAWS CHAIR

- A. The following Department of Hawaii Bylaws change was recommended.

Section 405. Department Officers

Part A Currently reads:

The Officers of this Department shall be as provided in Article V of the National Bylaws.

Should read:

The Officers of this Department shall be as provided in Article V of the National Bylaws. In addition the Judge Advocate and Surgeon are also elected.

The Bylaws Committee moves that this change be adopted.

Motion was seconded and passed.

- B. Bylaws Committee member Barlett reported that the same two (2) resolutions were received from Post 10154 and Post 12138 It was approved by Post 10154 on May 23, 2023 and Post 12138 on May 27, 2023. The resolutions are as followed.

- C. Resolution 1:

### **Resolution to Create Patrol Insignia Awards for the SS, SSG, SSN, and SSGN Submarine Crews**

Whereas the Veterans of Foreign Wars of the United States (VFW) is “a national association of veterans who as soldiers, sailors, marines, and airmen served this Nation in wars, campaigns, and expeditions on foreign soil or in hostile waters,” and is committed to “Ensure that veterans are respected for their service, always receive their

earned entitlements, and are recognized for the sacrifices they and their loved ones have made on behalf of this great country.” and

Whereas the mission of the VFW is “To foster camaraderie among United States veterans of overseas conflicts. To serve our veterans, the military and our communities.” And especially “To advocate on behalf of all veterans.”

Whereas the SSBN Deterrent Patrol Insignia was approved and authorized to be issued to members of SSBN, Boomer, submarine crews in 1969 and retroactive to the first deterrent patrol of the USS George Washington SSBN 598 in 1961, and has been issued to all crews of these submarines to the present after completion of an SSBN deterrent patrol, and

Whereas the SSBN Deterrent Patrol Insignia has been referred to by the US Navy as the successor to the World War II era Submarine Combat Patrol Insignia (SCPI) and as an insignia that is a combat insignia or badge, and

Whereas the Navy failed to issue an equivalent, appropriate, and consistent combat patrol insignia or award to SS, SSG, SSN, and SSGN crews and opted for the awarding of the Navy Expeditionary Medal (NEM) as a combat award for these crews albeit inconsistently, and

Whereas the SSBN Deterrent Patrol Insignia has been a divisive award within the Submarine Force, diminished Force cohesiveness, and a negative influence on Force morale, and

Whereas the above has extended to the Submarine Force veterans and the VFW and resulted in SSBN crewmembers and veterans receiving recognition for eligibility for membership while many SS, SSG, SSN, and SSGN crewmembers and veterans being excluded from membership even though they have participated in many deep water, extended, sensitive, and extremely hazardous patrols, without being awarded an Expeditionary Medal.

Now, therefore, be it Resolved, the members of VFW Department of Hawaii request that the VFW National Headquarters and leadership commence efforts to petition US Navy Submarine Force commands, commanders, and US Navy officials at the Pentagon to design, approve, and authorize patrol insignias for the SS, SSG, SSN, and SSGN crews retroactive to 1947 and holding the same award rank as the SCPI and SSBN Deterrent Patrol Insignias.

Post 10154 approved this resolution on May 13, 2023

Post 12138 approved this resolution on May 27, 2023.

D. Resolution 2:
